



SCORE LTD T/A SCORE | WAIVER FORM

In consideration of being permitted by 5SCORE Ltd t/a 5SCORE, to participate in its activities and to use its equipment and facilities, now and in the future, I hereby agree to release and forever discharge 5SCORE Ltd t/a 5SCORE, its agents, owners, members, shareholders, Directors, partners, employees, volunteers and affiliated entities and successors (the "Released parties") as a participant, guardian and/or supervisor of the child/children as follows:

1. I wish for myself and/or the child/ children, to participate in the activities organised by 5SCORE Ltd (CRN 12178661) trading as 5SCORE ("the Company") whose registered office is at Innovation Centre, Mewburn Road, Banbury, Oxfordshire, OX16 9PA.
2. The activities referred to, include but are not limited to indoor sports, bubble-football, fitness classes, party-room access, gym and studio access, upstairs mezzanine access, and associated activities (collectively hereinafter called "the Activity"), as organised by 5SCORE and/or a third party.
3. I confirm that I am 18 years or older and confirm that the child/children partaking in activities, is/are under 18 years old but over 6 years old.
4. If applicable, I declare that if I am not the parent or legal guardian of the child/children, I have authority from the parent or legal guardian of the child/children to sign this Disclaimer and Injury Waiver Form. Whilst attending 5SCORE and whilst participating in the Activity, the child/children will be under my care and supervision or alternatively, I will ensure that the child/children will be placed in the care and supervision of a suitable adult with my full permission.
5. I, as the parent/guardian/supervisor of the participant, acknowledge that their participation in any and all of the activities provided by the Company and third-party providers, entails known and unknown risks that could result in physical or emotional injury, paralysis, death or damage to themselves their property or to third parties.
6. I, as the parent/guardian/supervisor of the participant, warrant that I will comply and ensure that the participant complies with all written and oral safety instructions and advice provided by 5SCORE, at all times whilst on the premises from which the activities will be carried out. In particular, not to wear mouldies, blades, studs or to play in socks or bare feet whilst on the pitches.
7. I acknowledge that as a participant, relevant guardian or supervisor, I am responsible for my own safety and the safety of others under my care whilst partaking in the activities of 5SCORE.
8. The participant warrants that they comply with any age restrictions that may be in place by the Company from time to time to include the following:
 - Age restrictions for indoor & bubble football = Age 6+
9. I acknowledge and accept that the Activity requires a moderate level of fitness and is physically testing.



- 10. I confirm that I do not know of any medical condition that I or any of the child/children may suffer from, which might have the effect of making it more likely that I or any of the child/children be involved in any incident which could result in injury to myself, the child/children or others.
- 11. I acknowledge and accept that by participating in the Activity, I and/or the child/ children are exposed to the possibility of personal injury or death and/or property damage and I accept this risk on my behalf and on behalf of the child/children.
- 12. In the event of an accident involving myself and/or the child/children, I acknowledge and accept that SCORE Ltd t/a SCORE, will not be liable for any direct or indirect loss, damage or injury arising from or in connection with my and/or the child/children's participation in the Activity and I hereby waive all and any claims against SCORE in this respect and in respect of myself and/or the child/children.

I hereby indemnify SCORE against all claims made by any other person against SCORE in respect of any injury, loss or damage arising out of or in connection with my failure and/or the failure of the child/children to follow safety instructions and/or directions of SCORE its management and/or staff or third party.
- 14. I acknowledge and accept that this Waiver may be pleaded as a bar to any action or proceedings taken by me and/or the child/children at any time against SCORE, arising out of or in connection with my and/or the child/children's participation in the Activity. I confirm that I am 18 years of age or older and acknowledge that I have read and fully understand this Waiver Form prior to signing.
